- STEP TWO:** Complete and sign this worksheet. If you are a dependent student, a parent signature is also required.
- STEP THREE:** Submit completed worksheet, 2006 financial documents, and any other information that we have requested to your campus financial aid office or return them to Central Financial Aid in the envelope provided.
- STEP FOUR:** Contact your campus financial aid office if you have questions or need assistance with this process.
