

## Instructions for Submission of the Domiciliary Appeal Application for Virginia In-State Rates

### ATTENTION

**The Domiciliary Appeal Application and all supporting documentation must be submitted as soon as possible in order to insure that a final decision has been reached by registration deadlines. All documentation supporting a case for in-state tuition must have existed for the entire year prior to the beginning of the semester. If you choose to complete the registration process before your domicile status has been clarified, you will be required to pay out-of-state tuition rates.**

If you are currently classified as **OUT-OF-STATE** for tuition purposes, but feel you should be considered **IN-STATE**, you should follow the steps listed below:

- 1) Review the domiciliary section of the Virginia Code or the State Council of Higher Education for Virginia's (SCHEV) guidelines for domiciliary determination. The guidelines are available at the **RESERVE** desk of the library at each campus and may also be found online at: <http://www.schev.edu/>
- 2) The accompanying Domiciliary Appeal Application must be completely filled out and submitted to the Domicile Office at your campus of record for consideration. If you are a dependent of your parent or legal guardian or wish to claim entitlement based on your spouse's domicile, you must submit the parent/legal guardian/spouse form as well. Note that this form must be completed by your parent, legal guardian, or spouse.
- 3) In order to fully evaluate your application for in-state rates, certain documentation is required, as noted on the Application and listed below. **IT IS YOUR RESPONSIBILITY TO PROVIDE ALL DOCUMENTATION THAT SUPPORTS YOUR CASE.**

Documentation which must be submitted, if applicable, with your Domiciliary Appeal Application is listed below. **PLEASE PROVIDE COPIES OF THESE DOCUMENTS - COPIES CANNOT BE MADE IN THE DOMICILE AND RECORDS OFFICE AND WILL NOT BE RETURNED.**

- 1) Your most recent Virginia and U.S. income tax forms
- 2) Virginia Driver's License
- 3) Virginia Vehicle Registration
- 4) Virginia Voter's Registration
- 5) If military or a dependent/spouse of a military member, a Leave and Earnings Statement (LES)
- 6) If non-United States citizen, copy of visa
- 7) Evidence of any additional social or economic ties to the state of Virginia
- 8) **A COVER LETTER, AS NOTED IN QUESTION 17, DOCUMENTING YOUR INTENTION TO INDEFINITELY MAINTAIN YOUR VIRGINIA DOMICILE**

NOTE: If you are submitting a parent/legal guardian/spouse form, the documentation noted above should be submitted for that person along with your Domiciliary Appeal Application.

- 4) Upon submission of the Domiciliary Appeal Application and all documentation, an intermediate evaluation of your domicile status will be made within 10 working days. At that time, you will be notified of your status in writing. If your status remains out-of-state, you will be informed of the College's final appeal process.

**INSTRUCTIONS TO STUDENT**

If you will be 24 years of age or older by the first day of the term in which you plan to enroll, you must complete this Student form. If you will be under 24 years of age and unmarried, or you will be dependent on a parent or legal guardian on the first day of the term in which you plan to enroll, you must complete this form and your parent/legal guardian must complete the Parent/Legal Guardian/Spouse form. If you are claiming domicile on that of your spouse, your spouse must complete the Parent/Legal Guardian/Spouse form.

This form and all supporting documents must be returned to the Domicile Office at your campus of record as soon as possible in order to insure that a final decision has been reached by registration deadlines. A decision will normally be reached within 10 working days of receipt. Supporting documents that should accompany this appeal include copies of Virginia driver and vehicle licenses, Virginia voter registration, Virginia income tax forms, and other documents that support your eligibility for in-state or reduced tuition rates.

Before completing this application you should read Section 23-7.4 of the Code of Virginia to determine eligibility for in-state tuition benefits. The statute and guidelines under which the college must operate are on reserve in each college library and may also be found online at: <http://www.schev.edu/>

In order to be eligible to receive in-state tuition benefits, an applicant must have been domiciled in **Virginia continuously for at least one year immediately preceding the academic term for which reduced tuition is sought.** The applicant also must have the intent to remain in Virginia indefinitely. (Special exceptions exist for special arrangement contract students, military students, military dependents, and non-residents paying taxes to Virginia.)

Requests for Virginia domiciliary status will not be retroactively approved for previous terms.
