- I. Call to Order: Judy Gill presiding. Other senators in attendance: Jim Mahlmann, Donald McGuire, Karl Moore, Richard Gill, Jim Holden; also attending: Anne Pinkerton, Sylvia Ross, Carla Cannon, Bill Reid
- **II. Approval of Minutes:** minutes were not available but will be circulated soon.

### III. Review of College Senate Meeting and Ad-hoc committee for Revision of FDEP

- A. Judy reported that Gary Noah, via the computer club, had donated a laptop that we will auction off as a fund-raiser for the Norfolk Campus Moss Scholar fund.
- B. Concern was expressed that Norfolk is under-represented on the College Senate and on the new FDEP Review Committee to be established in May. R Gill will look into this from the perspective of FTEs per campus.
- IV. Welcome New Senators Tom Ellis and Phyllis Gowdy are replacing Richard Gill and Ivory Warren. Bill Reid will be an alternate. We still need adjunct replacements for Robert Williams and Jim Mahlmann. Kia Hardy will replace Thomas Chatman as the senator from the professional faculty.

- B. Student success impact on class assignments (Judy Gill). Many questions here. Do alarms go off when the success rate in a class falls below 30%? 25%? 20%? Are these alarms just for online classes? Are they for a single semester or for a series of semesters? Shouldn't faculty members be warned that they are about to lose a class and be given an opportunity to restructure? Judy will discuss this with Dr. Boyd and take it to the College Senate as well.
